2. In, the event of cancellation, the entry fees, less £7 per person will be refunded on receipt of a S.A.E In the event of cancellation.
3. Entry fees can only be refunded after the closing date on production of a medical or Veterinary Certificate or in the event of abandonment an administration fee of £7 will be retained
4. There will be a £5 levy for any substitution of horse, rider or combination made after the closing date.
5. Legal Liability - Neither the organisers, employees or representative of these bodies accept any liability for any accident, loss, damage, injury or illness to horses, rider, spectators, land, cars/vehicles, their contents and accessories any other person or property whatsoever, whether caused by their negligence, breach of contract, or in any way whatsoever.
6. Correct riding attire must be worn at all times when mounted
7. A protective helmet, body protectors to current safety standards and medical armbands be worn by all competitors
8. All horses must be aged 4 and over
9. All dogs must be kept on their leads at all times.
10. Any person wishing to lodge an objection to the secretary should submit it in writing within 15 minutes of the result with a £20 deposit which will be retained if the objection is over-ruled.
